




In 2007-2008 it is noted the highest number of the clients.


Structure of the clients by residency 2005-2010 and 2011

A considerable percentage (28%) are the residents of other districts.


Structure of clients by gender 2011



In 2011, approximately 60% of the clients are females and 40% are males.


The number of organizations requesting legal services is very low.

Structure of clients by age 2005-2010 and 2011




In 2011, prevail the clients of 30-40 years old, coming from families with young children.

It has decreased the number of the clients up to 29 years old.


In 2011 is has increased the number of the senior clients, without income, of 60 - 69 years old.

Structure of clients by civil status 2011




It is noted that in 2011 it has increased the number of the married clients is the highest, therefore needing more assistance and support.

Structure of clients by civil status 2005-2010 and 2011




In 2011, compared to 2005 – 2005 the number of the divorced clients has increased by three times.

Structure of clients by composition 2005-2010 and 2011




In 2011, the number of the clients from the minorities in Albania has slightly decreased.

Structure of income source 2011




The number of the unemployed clients, clients working in informal jobs, pensioners has increased.

It must be noted that in 2011 it has increased the number of the clients benefiting social assistance and has decreased the number of the clients working in informal works and unemployed clients


Structure of living conditions 2011



Prevail the clients living in unlawful dwellings, barracks and rented rooms.


It has decreased the number of the homeless clients.

In 2011 it has increased the number of the clients living in informal dwellings and prisons and has decreased the number of the clients living in barracks or rented rooms


Source of Information of TLAS existence 2011

TLAS publications and information, also, play a key role.


Source of Information of TLAS existence 2005-2010 and 2011



In 2011, it has increased the number of "social insurance institutions" as source of information on TLAS.


Also, a substantial role play the recommendation from Ombudsman and other organizations or institutions.

Structure of problems addressed by TLAS 2011




In 2011, the birth registration cases concern the most of the cases addressed by TLAS (22%), followed by other family law cases.

Structure of problems addressed by TLAS 2005-2010 and 2011





From active cases of 2011, 43.2% are legal cases and 56.8% are paralegal cases.


Structure of case progress 2005-2010 and 2011



In 2011, it has increased the number of the cases solved by legal advice.


The legal cases addressed by TLAS lawyers are concluded in favor of the clients by court decisions.

Structure of families by family members 2007-2010 and 2011




In 2011 it has increased the number of the families with 3 members and 2 members and it has decreased the number of families with 6, 7 and over 7 members.

Structure of families by number of adult members 2007-2010 and 2011




In 2011, also, prevail the families with two adult members and is slightly increased the number of the families with 1 adult member.
